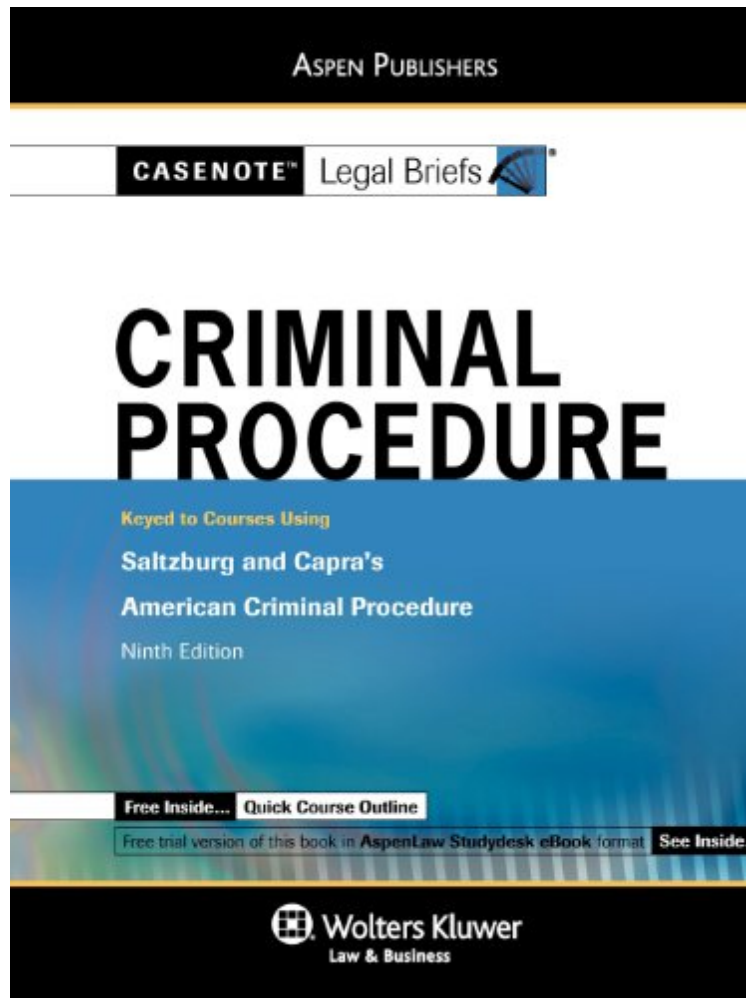

Sometimes those cases are discussed in a lot of detail and are more important than the "feature" cases. For some topics, all the cases are note cases. All of the note cases are excluded in this book, so more than 1/2 the cases from the book are missing. The briefs also seem to frequently miss the point the book is trying to get across.
