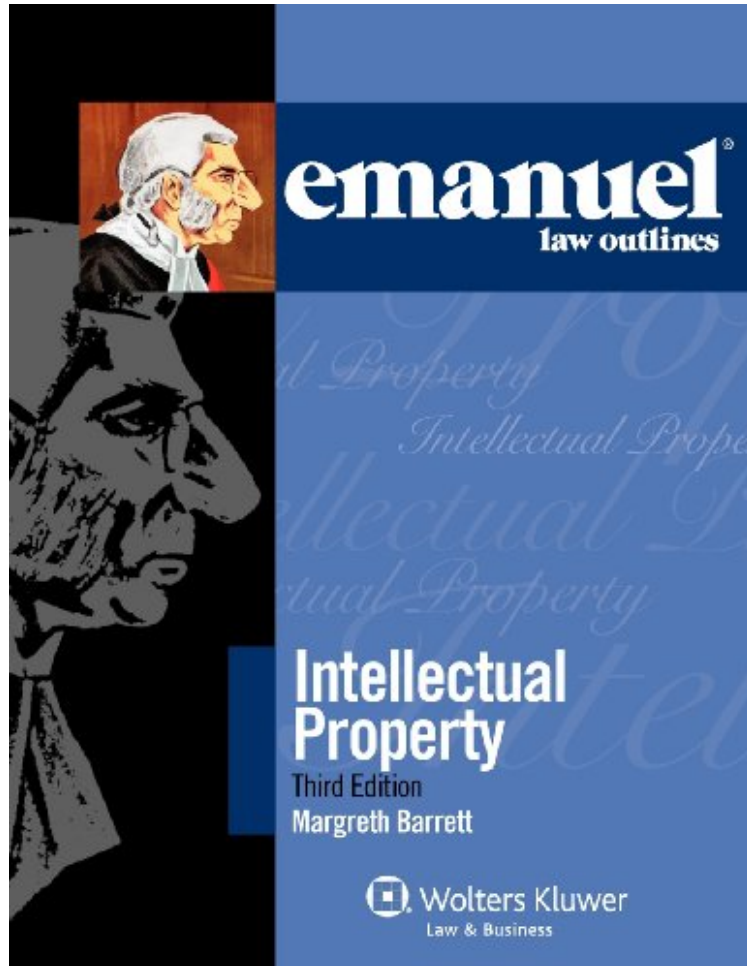

My course was a four unit ip survey class covering trade secrets, patents, copyright, trademark, and the law of undeveloped ideas. We didnt tackle right to publicity or other ip topics, but what we did cover was extensively outlined in this supplement. The supplement is conveniently keyed to other ip casebooks as well. What I really liked with this supplement is the generally straightforward way it's laid out and the amount of black letter law it includes. Sometimes certain sections were slightly repetitious, but on the whole this supplement was great. The only reason it's not a five star for me is that it's missing a few recent cases that change the law and there is no info on the Aspen site the book tells you to reference to find out about updates. Previously I've only used the understanding series and examples and explanations, but after my

experience with this supplement I'll certainly be considering Emanuel for any future purchases as well.
