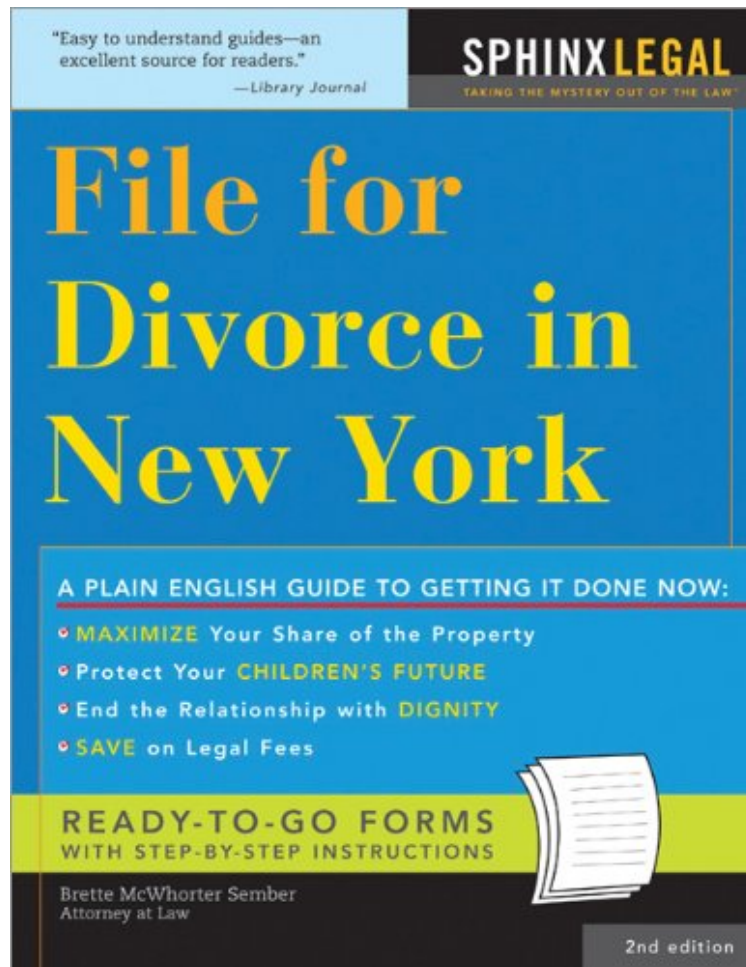

My partner and I labored a full 5 hours just trying to fill out some of the Forms following Ms. McWhorter's instructions. The instructions are confusing, to say the least. In many instances they are also outdated or plainly incorrect. We soon found ourselves on the NYCourts website for help. We also found that some of the "Ready-to-Use Forms" are outdated and incomplete. Pages are missing. And, although you have to check items on form after form, the checkboxes are missing on most of the forms. The next day I went to Court with the two initial forms filled out according to Ms. McWhorter's instructions. A kind clerk in Help Room 116 asked me where I got those forms and where I got that book. He then gave me a FREE package with the correct Forms and Filing Instructions, which my partner and I were able to fill out within 3 hours. All of them.
