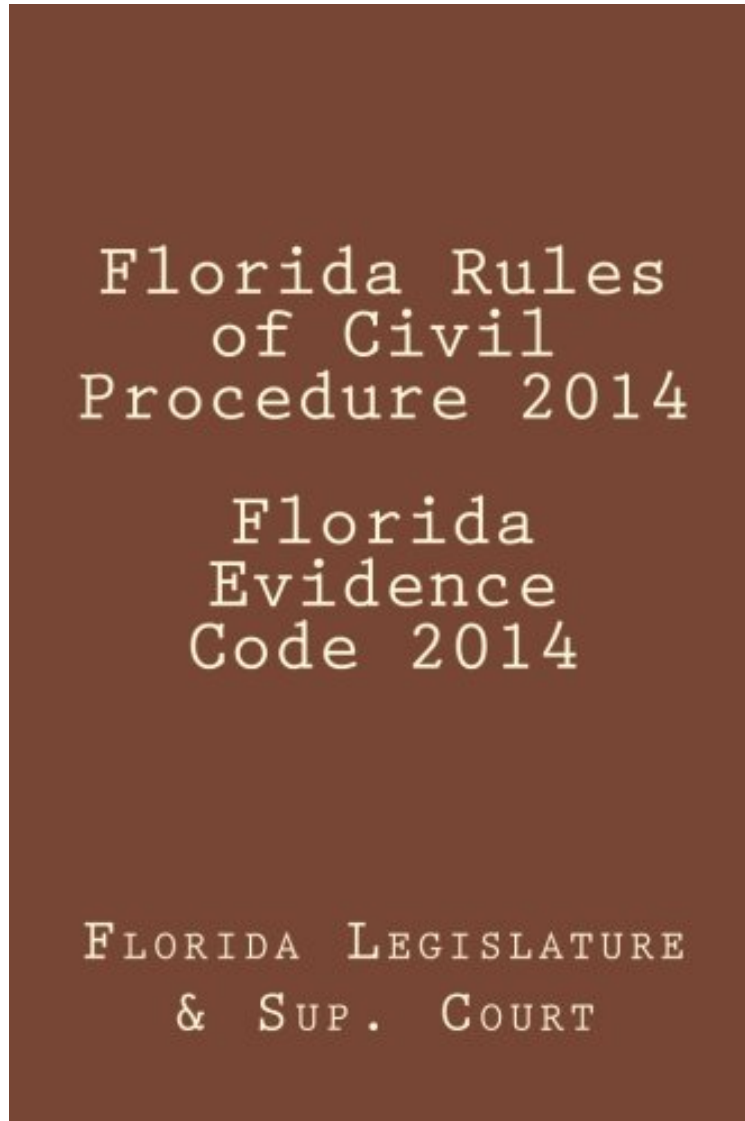

The book contains just the rules of civ pro and evidence. This makes it handy for court - it's small and light, with no unnecessary pages to flip through.The binding is solid, the cover is glossy and reasonably thick, and the text is clear. The print is a little small, but that's to be

expected in a rule book. I do find a few small flaws: the tables of contents for both "rules" appear at the front, instead of each appearing immediately before its corresponding rule; there are no leader dots in the tables of contents; the title on the spine of the book is so tiny and faint as to be illegible from book-choosing distance; and one edge of the back cover (on my particular model) is the tiniest bit jagged. These are pretty small flaws. My alternative to buying the book was printing out the two "rules," from the internet, on my computer. That would have cost me more in paper and toner than I spent on the book, and the resulting printout would have been less durable, less easy to store on a shelf, less easy to page through, and less easy to locate on a desk cluttered with white paper, than the book is. Overall a very good purchase. One last detail I like is that the book was printed to order - the back of the last page has the date '16 November 2015,' which is about a day after I placed the order.
