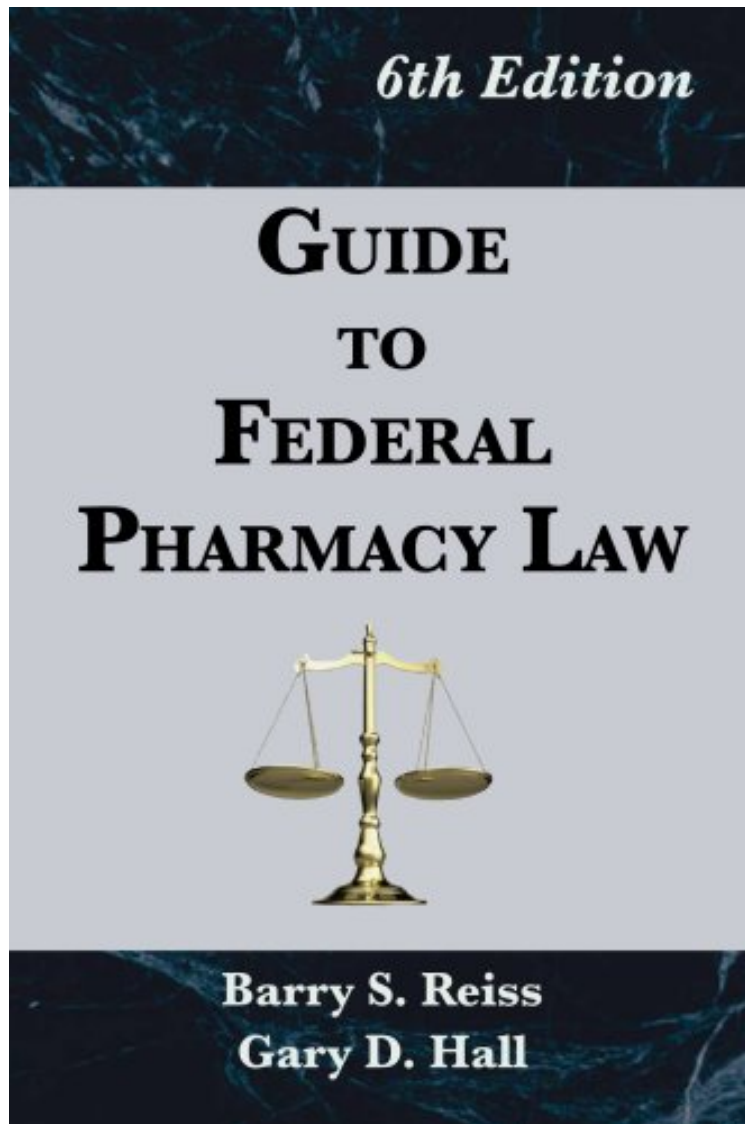

My only criticism of the book is that it omitted information on Medicare Part D.

There were questions on the subject in the final group of questions at the end of the book, but no chapter or information on the subject to study from.
